We currently don't have a set ratio and are looking at adopting some language that is more concrete. The Committee discussed aspects of a smaller group of students compared to larger groups as well as whether the trip is local

compared to out-of-state or country trips. Mr. Walters and Ms. Lam will discuss options and will either bring it back to Committee or directly to the full Board.

- b) Policy 3120.06 Selecting Student Teachers/Administrative Interns
  Jeff Walters shared the changes to this policy regarding the language to allow the District
  Administrator to designate another staff person to make selections.
- c) Staffing Update Kelly Lam shared some information regarding possible staffing changes for the 2023-2024 school year. We are looking at changing the titles of some positions to redistribute some duties, in order to attract the right person with the needed skills. Kelly Lam also addressed the staff to student ratios for the 2023-2024 school year. We are looking to keep our classroom sizes lower for the betterment of our students. This is the driving force to determine needed full-time employment positions.
- d) Job Descriptions Jeff Walters discussed the updated job descriptions and our process for finalizing the changes. Some changes are minor and others are updating duties and titles. The job descriptions will be brought to the full Board in April.
